Applications will be accepted beginning January 16, 2024, until March 18, 2024. March 18 at 5:00 pm will be the deadline to submit any Applications or information missing from previously submitted but incomplete Applications. Please note that Applications received less than 10 business days prior to March 18, 2024, may not be reviewed for completeness before the deadline. Interested applicants are encouraged to submit Applications early to have the greatest opportunity to be reviewed and have time to correct any errors or omissions. An applicant who is found to have applied for or received incentive funds from another entity or program for the same equipment or engine without disclosing that information shall be disqualified from funding for that project from all sources within the control of an air district or CARB. The air district or CARB may also seek penalties for such non-disclosure.

**Submit one application per person/business/entity.** Information to assist you in completing this Application is available in the 2018 Funding Agricultural Replacement Measures for Emission Reductions (FARMER) Program Guidelines, available on the District's website [www.fraqmd.org](http://www.fraqmd.org) or <https://ww2.arb.ca.gov/sites/default/files/2018-07/farmerguidelines-final.pdf>. Please note that additional information may be requested from the applicant in order to process this application.

## General Eligibility Criteria

To be eligible for funding, projects must meet the criteria described in the 2017 Carl Moyer Program Guidelines, the FARMER Program Guidelines, and all current Carl Moyer Program Advisories. These criteria include but are not limited to the following:

- Emission reductions obtained must not be required by any federal, state or local regulation, memorandum of agreement/understanding with a regulatory agency, settlement agreement, mitigation requirement, or other legal mandate.
- Projects must meet a cost-effectiveness established by the District and calculated in accordance with the cost-effectiveness methodology in the 2018 FARMER Guidelines.
- No emission reductions generated shall be used as marketable emission reduction credits, or to offset any emission reduction obligation of any person or entity.
- No project funded shall be used for credit under any federal or state emission averaging banking and trading program.
- Funded projects must have at least 75 percent of their total activity for the project life in California.
- Emission reduction technologies must be certified/verified by the ARB for sale in California and must comply with durability and warranty requirements.

## Off Road Vehicle Eligibility Criteria

- The existing vehicle can be an ATV or an UTV. Tractors with less than 25 horsepower are eligible for replacement as well.
- The existing vehicle must be used in agricultural operations.
- The new UTV must emit zero tailpipe emissions from its onboard source of power (such as all electric or hydrogen fuel cell vehicles) and may not go under any modification that would allow propulsion by any other means.
- The new UTV must have a towing capacity of 500 pounds or greater and a total vehicle weight of 700 pounds or greater.
- The owner and equipment must be in compliance with federal, state, and local regulations. Use the tables below to determine if existing equipment is eligible for funding.
