## **Woodsmoke Reduction Pilot Program**

The Woodsmoke Reduction Pilot Program is an upcoming incentive program funded by California Climate Investments and administered by local air districts. This program provides vouchers to replace non-EPA certified wood-burning stoves and fireplace inserts with either an EPA certified woodstove or insert, a natural gas or propane stove, or an electric heating device.

For certain communities designed by the state and for low-income households, the vouchers may cover the entire cost of the replacement (up to \$3,500). A standard voucher of \$1,000 is available to all households regardless of location or income in Yuba and Sutter counties to use to reduce the replacement cost.

May Is Bike Month!

May is Bike Month is a campaign that takes place in the six-county Sacramento Region each year. The focus of the campaign is to promote bicycle use as a mode of transportation whether for running errands, commuting, or recreation. Participants sign up at the website <a href="http://www.mayisbikemonth.com/">http://www.mayisbikemonth.com/</a> and log their miles. The Yuba-Sutter area May Is Bike Month events are listed on the website.

Home owners and tenant occupied residential homes in Yuba and Sutter counties are eligible. Tenant applicants must obtain owner approval prior to receiving a youcher.

The Program will begin in May 2018. Applications will be available when the program begins. To apply, fill out an Application and take a photo of your old device. Send the completed Application and photo to the air district by mail, email, or drop off at the office Feather River Air Quality Management District, 541 Washington Avenue, Yuba City, CA 95991, email: fraqmd@fraqmd.org.

Once the program begins, vouchers will be issued first come, first served, and expire 4 weeks from the date they are issued. Within the 4 weeks, the applicant must shop around from the list of participating retailers, select a replacement device, and give the voucher to the retailer. Installation is not required to be completed within 4 weeks. Vouchers are only good at participating retailers and for installations done by licensed contractors; do-it-yourself installations are NOT allowed under this program.

Retailer trainings will be held on May 1st at FRAQMD in Yuba City, May 2nd in Chico, and May 3rd in Redding and Grass Valley. The Mini Grant Program is now accepting applications for small projects (\$2,000 and less) such as public bike racks, May Is Bike Month energizer stations, public EV chargers and public education. Mini Grants are awarded on a first come/ first served basis.

The deadline to apply for a Mini Grant is May 31, 2018.

### **Ozone Season Starts May 1st**

"Ozone Season" occurs May 1st though October 31st, and signifies the time of year when ozone levels can exceed the health based standards. Air pollution can harm everyone, and ozone is especially harmful to those with respiratory and heart illness, older adults, young children and people who are active outdoors.

The U.S. Environmental Protection Agency lowered the ozone standard in 2015 to 70 parts per billion (ppb). The Yuba City-Marysville area, all of Yuba County, and most of Sutter County are meeting the new standard. A design value is the 3-year average of the 4th highest 8-hour average ozone levels. The Yuba City monitor had a design value of 65 ppb in 2016.

The Sutter Buttes Monitoring Station is a special purpose station and has it's own "nonattainment area" which is located around the South Butte above 2,000 feet elevation. South Sutter County is part of the Sacramento Federal Nonattainment Area and is not meeting the 2015 Ozone Standard.

Here are some ways to reduce ozone emissions:

- Don't top off your gas tank
- \* Avoid refueling when it's hot outside
- \* Plan your trips so you reduce the times you start and stop your vehicle
- Ride a bike, walk or take transit instead of driving
- \* Turn up the thermostat on your air conditioner
- \* Pack a lunch to eat rather than driving to buy lunch
- Keep your vehicle well maintained and your tires properly inflated
- Use low VOC paints and thinners

Residents can check current air quality levels and sign up to receive daily air quality forecasts at <a href="www.airnow.gov">www.airnow.gov</a>. ### **Community Air Protection Program (AB 617)**

The State of California adopted Assembly Bill (AB) 617 (Chapter 136, Statutes of 2017) with the intent to identify and reduce exposure in communities most impacted by air pollution. The bill mandated several things including: community air monitoring; community emissions reduction programs; funding to support cleaner technologies in these communities; and grants to support community participation in the AB 617 process. AB 617 also includes new requirements for accelerated retrofit of pollution controls on industrial sources, increased penalty fees, and greater transparency and availability of air quality and emissions data, which will help advance air pollution control efforts throughout the State.

The District adopted changes to it's Mutual Settlement Policy in December 2017 in response to AB 617. On April 2, 2018, the District Board of Directors adopted by resolution the grant award with CARB to implement the AB 617 program. In April, the District will provide information on AB 617 to Local Agency staff. And later this year, the District will hold community meetings in SB 535 communities in Yuba and Sutter counties.

The District is undergoing a technical review of communities and emissions within Yuba and Sutter counties. If a community is identified as one of the most impacted statewide, the District will be recommending it to CARB by April 30, 2018. CARB will be adopting the first year communities by October 1, 2018, as well as sites for community monitors.
